

OROI SCHOOL (1870)

ENROLMENT SCHEME

Effective from 12 October 2015
(Amended in July 2018)



The guidelines for development and operating of enrolment schemes are issued under section 11G (3) of the Education Act 1989 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below (and shown on the attached map) shall be entitled to enrol at the school.

The zone starts at the intersection of No 2 Road and Mountain Road (but does not include No 2 Road). The boundary tracks north-west overland to cross Oropi Road south of 1714 Oropi Road – all addresses less than, and north of 1714 and 1681 Oropi Road are within the zone boundary.

The boundary then travels north, west of Glue Pot Road, to include all addresses on Glue Pot Road (with the exception of 333 and 355B Glue Pot Road, which are not included in the zone).

From the northern end of Glue Pot Road, the boundary continues north, west of Oropi Road to include addresses on Oropi Road (Including and south of numbers 228 and 215), as well as all “no-through” roads off Oropi Road including: Jacks Lane, Castles Road, Nga Parae Road, Wood Road, Phillips Drive, Waioroi Place, and Pinasta Place.

The boundary intersects Oropi Road at number 228 and traces south-east to include all of Pukemapu Road; it then intersects Ohauti Road at number 322 so that all addresses including, and south of, 322 and 375 are within the boundary. (The boundary does not include Boscobel Drive and Rowsdale Drive, and all adjoining roads).

The boundary tracks south, to the east of Ohauti Road, Rowe Road and Kaitemako Road South. From the southern end of Rowe Road, the boundary runs south back to the starting point at the intersection of Maintain Road and No. 2 Road. All of Mountain Road and Seales Road are inside the boundary. (NB, as per above, the zone does not include No. 2 Road).

Out of Zone Enrolments

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Special Programmes

Oropi School operates the following the Te Kōkako o Ōtanewainuku special programme.

The criteria for acceptance into this programme is that Ōropi School is the nearest, suitable bilingual/immersion option for students who either:

- have been to kohanga reo, puna reo or who are transferring from another rūmaki or bilingual unit;
- are coming from an immersion environment at home; or
- are coming from a home where whānau are making a long term commitment to Māori immersion education.

Students who live within the school's home zone and meet the criteria for enrolment in the special programme will be enrolled ahead of out of zone students.

Applications for enrolments will be processed in the following order of priority:



- **First priority** must be given to students who have been accepted for enrolment in the above mentioned special programme run by the school and approved by the Secretary for Education.
- **Second priority** must be given to applicants who are siblings of current students.
- **Third priority** must be given to applicants who are siblings of former students.
- **Fourth priority** must be given to any applicant who is a child of a former student of the school.
- **Fifth priority** must be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
- **Sixth priority** must be given to all other applicants.

If there are more applicants in the second, third, fourth, or fifth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary. Under Section 11G (1) of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
